Breeding Contract

1. I _____ agree to breed my mare, _____
Reg No. _____, Sire _____, Dam _____
to the stallion GENTLEMAN SEND ROSES, for the 2017 breeding season. The stud fee shall be 850.00. Total due by December 15, 2016 .
2. Mare owner agrees to pay \$14.00 per day for mare care wet or dry.
3. There will be a chute fee of \$250 with this contract and includes the first shipment. No chute fee if mare is brought to the farm to breed.
4. Shipped semen is available and shipped at \$200 a shipment after first shipment. Container will be returned to Harnish Performance Horses within 7 days. No shipments will be made without stud fee and applicable chute fee paid. A pick up fee of \$75 will be charged for any semen picked up at the farm or delivered. Shipments will be billed within 10 days of shipping and are due upon receipt. If not paid no further shipments will be made.
5. Without 24 hours notice, GSR Investments and Harnish Performance Horses cannot guarantee shipment of semen to mare owner. Notice shall be the mare needs semen or that the mare is being checked. Collections are made Monday Wednesday and Friday.
6. Mare shall be in a healthy and sound condition, free from infections, contagious and transmittable diseases. A current cognins test and a photo copy of registration papers will be given to stallion owner when mare is delivered.
7. This contract contains a "live color foal guarantee". A color live foal is described as a newborn foal, which stands and nurses without assistance and is eligible for regular registry in APHA. If foal is born dead, there are return privileges for the 2018 season only if stallion owner is notified within 5 days and receives a veterinarian's statement confirming death. If after being pronounced "safe in foal" the mare should miscarry, abort or prove barren, mare owner has the privilege to return for the remainder of 2017 season or return in the 2018 breeding season. A \$200 rebreed fee will be charged for all contracts carried to 2018.
8. A "Breeder's Certificate" will be issued for the foal, conceived by this mating, when stallion fee, all expenses have been paid in full and a live foal has been produced.
9. Both parties agree that GSR Investments, Harnish Performance Horses, Julie and or Brent Harnish, their agents and employees are not liable for accident, sickness or death to above named mare while in the care of stallion owner. Harnish Performance Horses will exercise the best judgement in care and supervision of mare and/or foal.
10. If mare dies or is sold, GSR Investments, the stallion owner, has the option to accept a substitute mare.
11. Mare owner agrees to pay for any and all veterinary costs incurred during the time mare is at Harnish Performance Horses. Veterinary care may be administered at the discretion of breeding manager.
12. This contract is non-assignable and non-transferable.
13. When both the stallion owner and the mare owner sign this contract it will then be a binding contract subject to the above terms and conditions. This contract is entered into in the state of Indiana and will be enforced under laws of Indiana.
